Dear Sir,

1. With reference to office of Election Commission (2023-25) Head Quarter MES BUILDERS ASSOCIATION OF INDIA (Regd.) letter Nos MBAI/Election/02/2023-2025 Dt: 02.05.2023, 1.MBAI/Election/03/2023-2025 Dt 02.05.2023 and MBAI/Election/04/2023-2025 Dt. 02.05.2023 (available on HQ MES BAI website www.mesbai.co.in)
2. It is informed to all the esteemed members of the branch that as per the decision of Executive meeting of the branch held on 25.05.2023 at Tsokjung Complex, Spituk Market, L Lobzang Gormet, index n.o E-30 of the MESBAI index n.o 399336 has been elected as the Election Chairman to conduct the AGM/Biennial Election of Branch for the term 2023-2025, the same will be held on 25th June 2023 from 3.00pm onwards at Tsokjung Complex, Spituk Market. The Branch election will be held as per provisions defined in MOA Para 11 through Election process during the meeting.
3. Annual subscription and other Branch dues has to be paid by 17th June 2023. Any member who is desirous to contest the branch election, and should not have any dues towards the branch outstanding. Then the member will be eligible for contesting the Election.
4. Members who have cleared their dues by 17th June 2023 will have the voting rights in the branch Elections.
5. Only the enlisted contractors whose names are being figured in the original valid documents issued by the MES Enlisting Authorities would be eligible to contest/participate in the elections. In case of Partnership Co. or Limited Co. only one person of the company can contest the branch election and voting right shall also be for one person only. In case of Proprietorship only Proprietor is authorized to contest/vote. Therefore, the members are requested to submit their valid latest enlistment/re-enlistment copies issued by the MES Deptt. before OR up to 17th June 2023 in the Association Office to make them eligible for contesting Election/Voting.
6. Eligible criteria for the post of Branch Chairman and Hony Secretary must have served 04 (Four) calendar years! Two tenures of any post of all the executive committees of branch.
7. Only enlisted contractors shall have right to contest/vote, but Associate members will not be having any right to contest/vote. A newly enrolled member will not be eligible to

8. As per letter No MESBAI/Election/12/2023-25 Dt. 16.5.2023 from Chief Election Commissioner (New Delhi) where he has given clarification for the period of 2019-20 and 2020-2021 i.e. (2019-21) was declared a zero term and accordingly tenure of branch executive body as well as Head Quarter Office bearers and council members was extended by two years i.e. up to 2023 and hence period of (2019 3) will be treated as one term of two years for the purpose of eligibility criteria for the post of Chairman/Hony Secretary.

9. As per para 27.5 (g) MOA any Chairman who has served a full term is not eligible for the post of Hony Secretary can only contest after a gap of one tenure.

10. Election process shall be adopted as per the MOA
