## From the Desk of President MES BAI "Sahi and Sachi Baat" Communication No 5 Dated 09 Jun 2025

To,

All Members  
MES Builders Association of India

Dear MES BAI Members

Greeting of the Day.

This is in response to the message being circulated regarding the filing of a caveat before the Hon'ble Delhi High Court on 20.03.2025 i.e. well before the Bhopal Council meeting when election process for 25-27 Term was started and that caveat has nothing to do with present circumstances in the name of MESBAI.

Let me clarify, unequivocally, that this step was taken in good faith and with the knowledge of the Hon. General Secretary. It was a necessary legal safeguard in view of the sensitive and serious issues confronting the Association.

1. Few complaints had been received by MESBAI HQ from members objecting to certain recent developments, including the amendment made to the Memorandum of Association (MoA) and Articles of Association (AoA)— amendments that were not agreeable small fraction of members who have also threatened to file court cases.
2. Representations were also submitted to the Office of the Registrar of Societies, Jamnagar House, Delhi, bringing these concerns to official attention.
3. Given the gravity of the issues and to prevent any ex parte action, the caveat was filed to ensure that MESBAI's interests are adequately protected in any related proceedings.
4. We must not forget that two cases are already pending before the Hon'ble Delhi High Court, and in recognition of the complex and delicate nature of the disputes, the Hon'ble High Court has proposed a mediation process, appointing Hon'ble Mr. Justice Vipin Sanghi (Retd.), former Chief Justice of Uttarakhand High Court, to help resolve differences amicably vide order dated 04.06.2025.
5. It is disappointing that certain individuals are attempting to project a legally justified and transparent step as an act of subversion. Far from being a misuse of MESBAI's name, the caveat is a tool to uphold due process and protect the Association from further unilateral actions especially at a time when internal trust needs rebuilding, not further erosion.
