Opening Remarks. Sh G.S. Mago welcomed all the participants and thanked them for joining the Virtual Conference Meeting.

Shri Sandeep Srivastava requested Sh G.S Mago to kindly liaise with the SO to E-in-C for seeking an appointment during the coming week. He emphasized that the renewal process is deteriorating day by day and an urgent discussion is essential to resolve the matter at the earliest.

Sh G.S Mago. Informed the members that a large number of telephone calls are being received from builders across the country regarding the denial of renewal of their enlistment of contracts due to the cancellation of tenders. He further stated that many builders are contemplating approaching the Hon'ble Court in this matter. Therefore, it is emphasized that the issue should be discussed with the E-in-C to ensure that the Association is not held responsible for any such legal action.

Sh Sandeep Srivastava. He requested Sh GS Mago to kindly bring this issue to the notice of the E-in-C through his SO highlighting that builders are prepared to approach the Hon'ble Court regarding the non-renewal of their contracts. He further pointed out that while the normal process of enlistment of contractors remains open, the cases related to renewal are not being processed in a fair and appropriate manner.

Sh G.S Mago.

He stated that E-in-C Branch should be apprised that in cases where contracts have been cancelled and the performance security has been forfeited along with imposition of other financial penalties, the renewal of enlistment should not be denied as the concerned builders have already been penalized. He further informed that he had a discussion with DGW the previous day. During earlier visits to the office alongwith the Hony Gen Secy and colleagues, it had been conveyed that the minutes had been approved by him and submitted to the E-in-C for final approval, however the matter remains pending to date. He also mentioned that his request for extension of the renewal of enlistment upto 31 March 2026 is still awaiting approval.

He expressed concern that despite several requests, some office bearers did not attend this important meeting which is essential to deliberate on the seriousness of the renewal of enlistment issue, affecting builders. He reiterated that numerous call are being received from builders across the country regarding the non-renewal of enlistment due to cancellation of contracts. He further informed the members that he has learned that the Eastern Command has renewed two cases involving cancellation of contracts and has subsequently written to the E-in-C Branch for their perusal and comments if any. In the absence of a response, they intend to continue the renewal process in such cases.

Sh GS Mago requested Sh Pankaj Kr. Prahladka VP to kindly verify this information, obtain a copy of the said letter and forward to us so that the matter may be appropriately taken up.

Sh Vinod Behl.

He informed the members that he has prepared and submitted approximately 16 appeals to the E-in-C Branch regarding the non-renewal of enlistment cases from builders across various parts of the country. He also stated that he has taken only one plea that for a single lapse, two punishments cannot be imposed under any law. The requisite amount was duly deposited and bids were submitted for a period of six months. However, all of a sudden, a ban was imposed and the case was not considered for renewal. This action is unjustified, and contrary to the principle of natural justice and also a violation of fundamental rights

Sh Sandeep Srivastava.

He stated that a decision can be taken as eight office bearers are present in the meeting. However, he proposed that a circular letter be issued on Monday to convene a follow up Virtual Conference in continuation of today's meeting.

Sh G.S Mago. He proposed that a resolution be drafted on the matter discussed today and circulated in the official WhatsApp group of the office bearers for their views and comments. He further stated that the Association may consider seeking legal remedy if not received any positive response from E-in-C office.

Sh Vinod Behl. He stated that the Association cannot independently pursue legal action in these cases and that such action should ordinarily be initiated by the individual builders who are affected. He further observed that while approaching the Hon'ble Court individually may be more expensive, in the interest of the welfare of the builders, the Association may assist by approaching the legal authorities on their behalf by mentioning the names of the concerned builders

He also highlighted that all renewals carried out across India up to the end of the year 2025 contained clear instructions permitting members to secure works up to 31 December 2025. However in certain cases, members who had secured works during September, October & November 2025 had their works and their fresh renewal application got rejected on the ground that permission was valid only up to June 2025, which is incorrect. This action is clearly contrary to the provisions mentioned in the renewal of enlistment letter, wherein it was explicitly stated that all members would be permitted to take up works up to 31 December 2025. It was further clarified that members were free to take up works from any government department without restriction.

Sh G.S Mago. He once again appealed to all office bears to ensure their presence in the forthcoming meeting. He then requested Sh Kumar Ashok to kindly share his views on the matter.

Sh Kumar Ashok. He agreed with the proposal and stated that earlier there was no such provision for denying the renewal of enlistment on account of the cancellation of contracts. However, he stated that this provision has now been implemented.

Sh. Mahesh Jain . He agreed with the proposal and stated that the matter should be pursued unanimously as a collective decision would be more effective.

Sh. Shiv Kumar Gupta . He agreed with the proposal. However stated that if we will direct show the legal attempt, it may be harsh to E-in-C branch. Therefore we should follow the channel of E-in-C.
