MEMORANDUM

We Members of MES BUILDERS ASSOCIATION OF INDIA (Regd.) _____ Branch submit through this Memorandum the grave Difficulties our contractors Fraternity is facing which may vanished our existence in future if not addressed at this juncture by appropriate Authorities of MES department at the Helm of affairs.

All our grievances / Difficulties being faced by us are Appended in succeeding Paragraphs:-

(1) NON RENEWAL OF LARGE NUMBER OF ALREADY REGISTERED CONTRACTORS IN MES FOR CYCLIC PERIOD 2025- 2032

(2) DENYING GENUINE FINANCIAL ASSISTANCE TO CONTRACTORS FRATERNITY TO SUSTAIN LOSSES ENCOUNTERED DUE TO MIDDLE EAST WAR PRESENTLY GOING ON

(3) NON ENHANCEMENT OF FINANCIAL LIMITS OF ALL CLASSES OF ENLISTED CONTRACTORS FROM LONG OVER DUE PERIOD (LAST FINANCIAL LIMITS ENHANSED IN THE YEAR 2010 FOR ALL CLASSES).

(4) PENDING RECLASSIFICATION (ENHANCEMENT OF TENDERING LIMITS), TENDERS OF " E" CLASS SHOULD BE OPNED UP TO Rs 50.00 LAKH Value (LIMITS up to which GE's are permitted to Tenders) WHICH WAS IN PRACTICE w.e.f. 2015 TILL NEW MANUAL ON CONTRACTS 2020 WAS IMPLEMENTED.

(5) TO RELEASE 100% PERFORMANCE SECURITY IMMEDIATELY AFTER COMPLETION OF WORK AS BEING DONE IN CPWD , AT LEAST RECOMMENDATIONS OF THE BOARD CONSTITUTED ON THIS MATTER WHO GIVES ITS RECOMMENDATIONS AFTER DETAILED EXAMINATION OF PROVISIONS OF COUNTER PART CONSTRUCTION AGENCIES OF CENTRAL GOVERNMENT .

(6) GLITCHES IN OPERATIONS IN E- MB WHICH IMPLEMENTED WITHOUT ADEQUATE GROUND WORK FOR INFRASTRUCTURE NEEDED FOR THE SAME. THIS UNNESSARY DELYING DUE PAYMENTS OF CONTRACTORS WHICH EFFECTS CASH FLOW IN THEIR ONGOING CONTRACTS

(7) MODIFICATIONS IN PRICE ESCALATION CLAUSE IN LINE WITH CPWD & RAILWAY PRICE ESCALATION CLAUSE IRRESPECTIVE OF JOB PDC OR CONTRACT PDC.

(8) REDUCING TIME OF ACCEPTANCE AFTER BID SUBMISSION END DATE , WHICH ARE PRESENTLY BADLY AFFECTED THE SMALL VALUE WORK EXECUTING CONTRACTORS. THE ROLE OF IFA BE CURTAILED UP TO SCRUTINY OF DOCUMENTS PRIOR TO ISSUE OF TENDERS & THEIR UNNESSARY INTERFERENCE IN RATES RESONABILTY BE RESTRICTED SINCE THEY ARE NOT QUALIFIED IN TECHNICAL ANALYSIS OF RATES & ALWAYS INSITING FOR REASONABILITY OF RATES BASED ON LPP
