**Sub: Intimation Regarding Quashing of Illegal Appointment of Ad hoc Committee for
conducting Re-election of MESBAI ,HQ**

Dear Sir,

1.It has been come to my Notice that you had constituted & **Appointed an Ad hoc Committee for conducting Re-election of MESBAI ,HQ** under your letter No MBAI/DRRC/Election/2023-2025/02 dated 15.09.2023 which is totally illegal.

2. After the examination of the contents of your letter, it is noticed by the undersigned that you had illegally acted upon as Chairman DRRC against the Bylaws of Association of Our Esteemed Association as prescribed under MEMORANDUM AND ARTICLES OF ASSOCIATION OF M.E.S. BUILDERS' ASSOCIATION OF INDIA (REGD) AS AMENDED UP TO 10-09-2022 (HERE IN AFTER REFERRED AS MOA & AOA). You're illegal Act of **Appointment of Ad hoc Committee for conducting Re-election of MESBAI, HQ by adopting fraudulent acts on your part; Under signed I, Lakhbir Singh, in the Capacity of Chairman DRRC Hereby Quashed the orders issued by you under your letter No MBAI/DRRC/Election/2023-2025/02 dated 15.09.2023 after consultation of matter with the other members of DRRC Appointed for the 2023-2025 Term by the Council in the 2nd Council meeting held at Delhi on 11/09/2023 as uploaded & available on MES BAI Website under letter No MBAI/DRRC/01/2023 dated 11.09.2023.**

2. You are hereby directed to refrain from acting as So Moto Chairman of The DRRC (Defunct) in near future since the New DRRC has been Appointed /Selected by the Council and in your so Called Defunct DRRC, you are only single member left over in the Defunct DRRC constituted for 2019-2021 period after resignation of remaining three member i.e. Shri Ashok Kandoi, Sh Satish Ghai & Sh Shaukat Ahmed Dar on 07/09/2023, 08/9/2023& 08/09/2023 respectively and disassociated them self from your **fraudulent acts** of issuing of so called Award dated 05/09/2023. Since your **fraudulent award have no legal sanctity which has been quashed by the Council in the Council meeting held in Delhi by adopting Resolutions as circulated under Circular No 03 dated 14.09.2023 as uploaded & available on MES BAI Website which are reproduced for your Perusal again :-**

(a) Resolved that decision taken by the defunct DRRC is declared null and void.

The council passed the resolution unanimously. Standing ovation was given by the House to the HQ office bearers team.

(b) It is resolved that the Election for the Term 2023-202 5 were conducted by CEC Sh. Rajeev Chowdhary and members of EC in a free, Fair and crystal clear. The Council appreciates the efforts made by EC in conducting the election of Branches and HQ in a freehand fair manner and the elections conducted by them for the term 2023-2025are valid and accepted/adopted by the Council

Council agreed and passed the resolution unanimously. Standing ovation was given by the House to Sh Rajeev Chowdhary Chief Election Commissioner for 2023-2025.

3.. In view of the above you are here by directed to repeal your letter No MBAI/DRRC/Election/2023-2025/02 dated 15.09.2023 regarding the **Illegal & fraudulent act for Appointment of Ad hoc Committee for conducting Re-election of MESBAI ,HQ forthwith otherwise DRRC will force to Recommend the Council to take Appropriate disciplinary action against you for disturbing the functionality of Association without any Authority.**

Kindly acknowledge and take appropriate action accordingly.
