4. The Council meeting was held under the chairmanship of Sh. G.S. Mago President, MESBAI.

5. Before start of council meeting National Anthem was sung by all the delegates present in the meeting.

### 6. Item 1 of Agenda - Opening remarks by President

President Sh. G.S. Mago welcomed all Council members to the second council meeting of the Association being held at beautiful venue India Habitat Centre, New Delhi. Sh. G.S. Mago stated that attendance is very good which is most encouraging. Past Presidents Sh. B.R. Kohli, Sh. Anil Raizada, Sh. Bharat Bhasin, Sh. Harish C. Bhatia and Sh. Lakhbir

Singh have spared their valuable time to grace the meeting. He welcomed and thanked to all of them for their nice gesture. He also welcomed and thanked Sh.Rajeev Chowdhary Chief Election Commissioner (2023-25). Sh.Mago stated that various Council members, Chairmen, Honey. Secretaries some from faraway places are present here, he welcomed and thanked to all of them.

He hoped that in future also large number of Council members would grace the meeting which would motivate the headquarter team. It being first meeting after election, he congratulated all Chairmen/ Honey. Secretaries and Council members on being elected for their respective offices.

Shri G.S. MAGO thanked all Council members for showing their faith in him by electing him on the coveted office of the President. He on behalf of headquarters team and his own thanked all Council members for electing a very dynamic team. He assured that all the headquarters office bearers would work hard to achieve greater heights for MESBAI.

President stated that we through meetings and correspondence with Departmental Officers will try to get the all pending issues resolved. President stated that after taking over the charge of coveted office of President, he along with HQ team of office bearers have met respected Engineer-in-Chief, DGW, Jt.DG (Contracts) and other senior officers and discussed pending issues specially related to Performance Security, pending cases of renewal of enlistment cyclic period up to 2025, Comprehensive mainatince contracts, enhancement of tendering limit of all classes and GST. It is a matter of pleasure that the response of the Departmental officers was very positive and constructive. He hoped that with your support we would be able to get the pending issues resolved at the earliest possible.

President Sh.G.S.Mago stated that as members are aware about the recent developments in the Association. After completion of HQ elections for the term 2023-25, a complaint was made by Sh.Bijender Singh who has lost the election for the post of Sr.Vice President to DRRC on 08.08.2023. As members are well aware that the DRRC under the Chairmanship of Sh.Balbir Singh Vij was nominated by the then President Sh.Anil Kapoor in 2019 for the term 2019-21. Though the term of office bearers of Branches and HQ was extended to 2021-23 by the AGM. However, no extension in Tenure was approved for DRRC after 2019-2021 Term, neither bythe Council nor by the thenPresident. Further, one of its member Sh.Zachariah P John had expired. No new member in his place was elected/selected by the Council/ TheThen President. The remaining three members viz. Sh.Satish Ghai, Sh.Ashok Kandoi, Sh.Shaukat Ahmed Dar and Chairman Sh.Balbir Singh Vij have taken part in election and contested for the post of Vice President Central B, Vice President Eastern B, Chairman Srinagar Branch and Council Member Nagpur Branch for the term 2023-25 respectively. Hence they were advised by the President Elected for 2023-2025 not to conduct meeting of DRRC being defunct body. However, meeting of the defunct DRRC was conducted by Sh.Balbir Singh Vij Chairman DRRC for 2019-21 in which Sh.Satish Ghai and Sh.Ashok Kandoi Members DRRC for 2019-21 took part. Without any discussion/deliberation Sh.Balbir Singh Vij forced them to sign on pre-typed decision brought with him and even without giving them time to read. Sh.Balbir Singh Vij behaved in very rude manner with me (President) and even didn't allow me and Hony.Gen.Secretary to speak saying that Ex-officio members have no right to take part in discussion/deliberations and even cannot sign the decision. It is understood that Sh Balbir Singh Vij even doesn't know the meaning of Ex-officio members and crucial role of Ex Officio members in the DRRC. President then stated that all the Chairmen, Hony.Secretaries of Branches and Past Presidents are council members (Ex-officio) by virtue of their post held by all in present & past and take part in discussion/deliberations and also vote on all motions/Elections. Is Sh.Balbir Singh Vij was not aware of that? He even asked me to leave the meeting hall which cannot be appreciated at all. Sh.Balbir Singh Vij has given his decision that the Chief Election Commissioner and Members Election Commissioner elected by the Council in its meeting held at Pune were not eligible being council members (ex-officio) hence the only the election of HQ office bearers for the term 2023-25 conducted by the EC is not valid. Since, the decision was given by the Defunct DRRC, I , as Elected President of Association and under the powers conferred to me as per MOA&AOA of Association , cancelled and nullified their decision and the so called illegal award. Even that, a group of members have gone one step ahead by sending letters to Commissioner of Police and to Prime Minister of India through Sh.Anil Mittar, member Delhi Branch requesting them not to allow the Association to conduct Council meeting in the pretext of G-20 submit restrictions though eventfully there were no restrictions on 11/09/2023. Members present condemned the action of Sh.Balbir Singh Vij & others involved in the complete scenario. Sh.Mago stated that the point regarding action to be taken against them will be discussed as per item of Agenda.

With this he once again thanked all members for sparing their valuable time to grace the meeting. President stated that agenda of meeting is very lengthy, therefore, he requestedHony.Gen.Secretary Sh.Sandeep Srivastava to take up the remaining points of Agenda. He requested Hony.Gen.Secretary to take up Administrative points first.

7. Hony.Gen.Secretary Shri Sandeep Srivastava thanked President.Sh.Sandeep Srivastava on behalf of all HQ office bearers and his own welcomed all council members to the 2nd council meeting of the year being held at beautiful venue "India Habitat Centre, New Delhi. He stated that attendance of Council members in the meeting is

historically very good which is most encouraging. Members from various branches, some from faraway places were present. He welcomed them and thanked them. Sh. Sandeep Srivastava congratulated all office bearers on being elected for the respective posts. He thanked all Council Member for having faith in him by electing as Honey. General Secretary. Hony.Gen.Secretary Sh.Sandeep Srivastava stated that minutes of previous two council meetings held at Pune on 26.04.2023 and Council(Election) meeting held at Delhi on 26.07.2023 are to be confirmed. Minutes of the meetings have been circulated vide Circular No.48 dated 22.05.2023 and Circular No.01 dated 31.07.2023 respectively, through whatsapp/e-mail, which he hoped all council members would have received. The minutes were also uploaded on website of the Association. No objection from any one has been received. He stated that if council agree, minutes of previous council meetings held at Pune on 26.04.2023 & at Delhi on 26.07.2023 be treated as read and confirmed. After consideration, the minutes of both council meetings held on 26.04.2023 & 26.07.2023 were confirmed and approved by the council unanimously.

Hony.Gen.Secretary Sh.Sandeep Srivastava stated that as President has stated in his opening remarks that today we would first take up the Administrative part of Agenda and then will discuss technical matters. The first agenda point in administrative matter is to constitute Dispute, Redress and Reconciliation Committee.

**10. Item 4 (a) of Agenda - To constitute Dispute Redress and Reconciliation Committee & Item 4(c) of Agenda - to constitute Constitution Review Committee.**

As per article 23 (b) of MOA: the DRRC consisting of the Chairman and four members, all five of them directly elected by the council/selected by the President, in case empowered by the Council, from amongst the council members.

He requested members that as per practice, President may be authorized to constitute Dispute Redress and Reconciliation Committee and other committees to assist HQ office bearers for smooth functioning.

Council unanimously authorized President to constitute DRRC and other committees.

Hony.Gen.Secretary requested President to announce the committees and names of its members.

President Sh.G.S.Mago thanked all council members for posing faith on him. He then announced names of five members on the DRRC for the term 2023-25.

**a) Dispute Redress and Reconciliation Committee**

2. Sh. Ajay Kumar Jain
3. Sh. Surjit Singh Khalsa
4. Sh. Papinder Singh Gujaral
5. Sh. Sanjay Mittal

President requested members of DRRC to elect Chairman amongst themselves. After discussion between members of DRRC selected by the President, Sh. Surjeet Singh stated that they have elected unanimously Sh Lakhbir Singh as the Chairman of DRRC amongst themselves for the term 2023-25.

Elected Chairman DRRC Sh. Lakhbir Singh thanked members. He stated that in case of vacancy in the DRRC, the power to select new member may be given to the Chairman DRRC so that Committee with full strength as per MOA shall function. Council agreed.

Sh. Vinod Behl stated that the DRRC should be elected with the election of HQ as the overlapping period of one month or so has very negative impact. Members stated that for this amendment to MOA would be required. Sh. R.M. Singhvi stated that new Constitution Review Committee is being constituted, will also consider this point.

Sh. Puran Singh Yadav stated that most of the members are not aware about the Dispute Distress and Reconciliation Committee (DRRC). He requested Sh. Lakhbir Singh to say few words.

Sh. Lakhbir Singh thanked President Sh. G.S. Mago, Hony. Gen. Secretary Sh. Sandeep Srivastava, other office bearers, council members and Past Presidents for showing faith on them for selecting five members of DRRC and they have elected me as Chairman DRRC. Sh. Lakhbir Singh stated that as regards role and functioning of DRRC, if time is given during Chairmen/Hony. Secretaries workshop he will explain.

**b) Constitution Review Committee**

Hony. Gen. Secretary stated that President has selected following members for the Constitution Review Committee:-

There was a resounding applause from the House.

c) Hony. Gen. Secretary stated that following more committees are to be constituted:

- f) Standing Committee
- g) Souvenir Committee

Sh. Sandeep Srivastava stated that if council authorize President to select members for the above committee. The Council authorized President to select members of the above Committees or any other committee unanimously.

Hony.Gen.Secretary requested council to consider and pass following resolutions:

- a) Resolved that decision taken by the defunct DRRC is declared null and void.

Council passed the resolution unanimously. Standing ovation was given by the House to the HQ office bearer's team.

**Resolution**

- b) It is resolved that Election for the term 2023-25 were conducted by CEC Sh.Rajeev Chowdhary and members EC in a free, fair and crystal clear. The Council appreciates the efforts made by EC in conducting the election of Branches and HQ in a free and fair manner and the elections conducted by them for the term 2023-25 are valid and accepted/adopted by the council

Council agreed and passed the resolution unanimously. Standing ovation was given by the House to Sh.Rajeev Chowdhary Chief Election Commissioner for 2023-25.

**Resolution**

- b) It is further resolved that HQ is authorized to incur all the incidental expenses / expenditure incurred / to be incurred due to the notices and vague decision of DRRC or by any other members of MES BAI in this regard.

**Resolution**

- d) President is authorized to appoint advocates and incur expenses for the same etc.

**Resolution**

- e) It is resolved that pending complaints if any will be forwarded to the new DRRC elected/selected for the term 2023-25.

**Resolution**

6. Individual members who were involved in this conspiracy of Defunct DRRC will be examined and if required necessary show cause notice etc will be issued by the President MESBAI.

**Resolution**

7. Resolved that President may take necessary action to terminate the members of DRRC and Sh. Anil Mittar for their Anti Association Activities after issuing Show Cause Notice.

**Resolution**

8. The Council authorizes HQ to incur any other incidental expenses required and take decision/necessary action for the betterment of builders.

**Resolution**

9. Council Authorize President to form and constitute any committee as required for smooth functioning of HQ.

Council agreed and approved all above resolutions unanimously.

**11. Item 4 (b) - To consider illegal decision given by defunct DRRC and action in the matter.**

Hony.Gen.Secretary stated that as members are aware to the fact that election of HQ office bearers were held on 26.07.2023 in a free and fair manner. Record number of council members had taken part in the HQ Election. Results were declared by the EC and new elected team of Office bearers for the term 2023-25 was installed. The President and office bearers of outgoing team had greeted the newly elected team with garlands. However, after completion of everything peacefully, a complaint was made by Sh.Bijender Singh to DRRC dated 08.08.2023. As you all are aware that the DRRC under the Chairmanship of Sh.Balbir Singh Vij was nominated by the than President Sh.Anil Kapoor in 2019 for the term 2019-21 only. Though the term of office bearers of Branches and HQ was extended to 2021-23 by the AGM. However, no extension was approved for DRRC(2019-21) neither by the Council nor by the President beyond 2021 and No election/ selection of DRRC Members was conducted for 2021-2023. Further, one of its member Sh.Zachariah P John had expired. No new member in his place was elected/selected by the

Council/President to complete the quorum of DRRC. The remaining three members viz. Sh.Satish Ghai, Sh.Ashok Kandoi, Sh.Shaukat Ahmed Dar and Chairman Sh.Balbir Singh Vij have taken part in elections FOR 2023-2025 term and contested for the post of Vice President Central B, Vice President Eastern B, Chairman Srinagar Branch and Council Member Nagpur Branch respectively. Hence they were advised not to conduct meeting of defunct DRRC with defunct & incomplete body to decide any matter related to Elections of 2023-2025 Term since they already taken part in the Election for 2023-2025 term. However, meeting of the defunct DRRC was conducted by Sh.Balbir Singh Vij Chairman defunct DRRC for 2019-21 in which Sh.Satish Ghai and Sh.Ashok Kandoi Members of defunct DRRC for 2019-21 were present. Without any discussion/deliberation Sh.Balbir Singh Vij had forced them to sign pre-typed decision which he was carrying with him and even without giving them time to read them. Sh.Balbir Singh Vij has behaved very rudely with the President and don't allow him as well as to me saying anything that Ex-officio members have no right to take part in discussion/deliberations and even cannot sign the decision. He even asked President to leave the meeting hall which cannot be appreciated at all. Sh.Balbir Singh Vij had given his decision that the Chief Election Commissioner and Members Election Commissioner elected by the Council in its meeting held at Pune were not eligible being ex-officio council members hence the elections of Office Bearers of HQ only (Not of the Branches for which elections were conducted under the overall supervision of Election Commission as per Articles of MOA & AOA of the Association and Based upon that Council was formed) for the term 2023-25 conducted by the EC is not valid. Since, the decision was given by the Defunct DRRC, President has cancelled their decision and a show cause notice was issued to them. Sh.Satish Ghai, Sh.Shaukat Ahmed Dar and Sh.Ashok Kandoi has submitted their resignation as members of Defunct DRCC and withdrawn from the committee and in the involvement in any manner in the decision taken by Sh Balbir Singh Vij and also withdrawn their signatures from the order published by the Sh Balbir Singh Vij. Further Sh Ashok Kandoi & Sh Satish Ghai in their separate letters intimated about the illegal action of Sh Balbir Singh Vij and conveyed that their signatures are taken by Sh Balbir Singh Vij forcefully on pre printed so called Award at the HQ office on 05/09/2023 without any discussions or deliberations on the matter under which he scraped the whole Election of HQ office Bearers.

Hony.Gen.Secretary stated that Sh Balbir Singh Vij have sent a notice through their advocate to all HQ office bearers not to act as elected office bearers. Copy of the same has also been endorsed by him to the E-in-C and other senior officers. All the Members condemned the action taken by Chairman of Defunct DRRC. Hony.Gen.Secretary stated that reply on the legal notice served by the Chairman of Defunct DRRC have already been sent by the HQ to all concerned.

It is surprised that Sh.Balbir Singh Vij has himself issued an illegal notice for re-election of HQ Office Bearers for the term 2023-25 in unauthorized manner as he has no way authorized to issue such notice in any circumstances as per the Articles of MOA & AOA of Association which stands **Void**.

Hony.Gen.Secretary stated that this news was deliberately spread by the Sh.Balbir Singh Vij & Anil Mittar through Social, Print and electronic media to defame the Association as well as elected office bearers.

He requested council to consider the matter and suggest further action to be taken.

Sh.R.M.Singhvi stated that the council should authorize President, & Hony.Gen.Secretary to take strict action against them and also terminate their membership of the Association.

Sh.Bharat Bhasin (Past President) stated that few members of Defunct DRRC have already rendered their resignation from the Defunct DRRC and disassociated themselves from the decision given by the Defunct DRRC and withdrawn their signature. Actually they have helped the entire fraternity. Hence suitable action may only be taken against the erring persons and the members who have withdrawn from the illegal act may be pardon.

Sh.Badri Mander stated that action of Sh.Balbir Singh Vij be treated as Anti Association Activities and action should be taken accordingly.

Sh.V.P.Sanjiv stated that Sh.Balbir Singh Vij have misguided members of Defunct DRRC as they have given resignation with remarks that they were not allowed to read the decision and got signed forcefully which is a crime & serious fraud. Secondly the contestant for the post of Chairman Delhi Branch who had lost election has spread news through electronic and print media and also sent a legal notice. His membership should be terminated immediately.

President stated that a show cause notice has already been issued to Sh.Anil Mitter. On receipt of his reply necessary action will be taken. Sh.R.M.Singhvi stated that keeping in view the sentiments of the Council, immediately after the time given in Show Cause notice, action should be taken. He stated that council should authorize President, Hony.Gen.Secretary and other HQ Office bearers to take action to terminate membership of Sh.Anil Mittar without submitting the matter to Council again.

President stated that as authorized by the Council, on receipt of reply of Show Cause Notices, in case the same is not found satisfactory, necessary action as per MOA will be taken against the Sh.Balbir Singh Vij & Anil Mittar.



Sh.Peeyush Mishra stated that action should also be taken on the complainant also who has leveled baseless charges on the eligibility of members of Election Commission.

President stated that resolution has already been passed by the Council. He stated that action will be taken after adhering all procedure so that the same should not be challenged in the Court of law afterward. Action will be taken after listening to them.

Sh.Naresh Vij stated that keeping in view the situation arises after election; a committee may be constituted to amend the MOA so that necessary amendment is made in the MOA&AOA to avoid such incidents in future. President stated that Constitution Review Committee has already been formed under the Chairmanship of Sh.V.P.Sanjiv. He had been served as Chief Election Commissioner in past also, hence he will consider all the necessary amendments required and also suggestion received from members/Branches.

Hony.Gen.Secretary stated that we have requested concerned members and Branches to remit the subscription however, there is no response. Their membership is proposed to be terminated. He requested council to consider. Sh.R.M.Singhvi stated that during the meet the E-in-C Session some arrangement should be made that builder members who come from PAN India should be able to meet head of the department E-in-C, DGW and other senior officers of E8 Section.

Sh.V.P.Sanjiv stated that some criteria for selection of Best Member and Best Branch should be fixed. Some marking system should be adopted. The criteria fixed should be informed to Regional Vice Presidents. The Branch shall apply for that same.

President stated that as regards dates of function is concerned we have taken the consent of the respected E-in-C and has booked the venue. Sh.Surjit Singh stated that it is good that date have been fixed in advance now builder members can booked their tickets timely. He stated that he is associated with the Association for the last about 35 years, he requested that VIP culture should be stopped.

President stated that builders have shown faith on them. He assured that it will be as like Janta Darbar and there would be no VIP culture.

Sh.Sandeep Srivastave stated that all are well aware the condition of our members in the function. He stated that we should discipline our members. We invite VIP senior officers and their families. There is need to make an enclosure however, we should not make any restriction. It is not necessary that we should start drinks. It is noticed that during cultural programme members are waiting for to start drinks. The Builder members should be free to meet the Senior officers there should be no restriction however, there is a need for an enclosure for VIP as at present we are not so much disciplined. Hony.Gen. Seceratedated stated that a copy of enlistment has been received. He requested council to consider and accord approval for the change. Council after consideration accorded approval.

**17. Any other (Administrative) matter with the permission of chair.**

Sh.Lav Vinayak stated that certain firms from Delhi have taken membership from Pathankot Branch. He stated that the firm should take membership in their nearby branch of the Association. Some members are already members from Delhi Branch and also taken membership from Pathankot Branch. President stated that as per provisions of MOA no member can take membership from two Branches. The firm should take membership at his home station and if he desire he can take additional service at any other station/Branch.

Sh.Sandeep Srivastava stated that it is vital point, he requested the newly constituted Constitution Review Committee to look into this matter while considering amendments to the MOA. It is noticed that E class contractors are quoting tenders at a distance stations from their place of enlistment. He stated that the contractors should be given membership from where he is enlisted. In case he is working at any other station he can take additional service at that station however, he can exercise his voting power at his parant Branch only. President requested Chairman CRC to look into this point.

Sh.Lakhbir Singh stated that in case any request is received from any Branch the same should be reviewed.

Hony.Gen.Secretary than took up the Technical matters.

**18. Item 3 (a) of Agenda – Follow up action on various technical matters.**

**Hony.Gen.Secretary stated that** action on various Technical/administrative matters brought out in minutes of last month's council meeting has been taken.

**19. Item 3 (b) of Agenda – To formulate plan of action for the year.**

Hony.Gen.Secretary stated that we do this exercise every year. We, at the start of the year, decide what important matters will be taken up with the Department during the year. Suggestions from Branches are also welcomed in this connection.

We had requested all Branches to send their suggestions so that hardships faced by their members if any, (remedy of which lies at the end of the E-in-C) could be included in the "Plan of Action". Few Branches have responded to our request and sent following points:

**Ranchi Branch**

- a) Reimbursement of GST on works before 18<sup>th</sup> July 2022.
- b) Unworksable rates and unethical practices at different GEs level
- c) Tenders of Gemp are manipulated.
- d) Many cases of Upgradation/reconstitution processed on CCEP portal are pending from CECC Lucknow

Sh.Lav Vinayak stated that manning and operation tenders are being issued through GEMP. He stated that though in MES E class contractors are facing problems in getting tenders above Rs.25 lakhs. However, at GEMP bids of E class contractors are being opened for tenders even upto 1 crores. He requested that this aspect should be looked into. Sh.Lav further stated that even from enlisted contractors in a particular category experience certificate is being asked for. Sh.A.K.Upadhaya stated that a policy letter was issued for comprehensive maintenance contracts. Though the same has been kept in abeyance for one year however he requested that this matter should be taken up with the Department not to implement such policy. Sh.Upadhaya stated that previously the MES category of contractors was being mentioned in the GEMP and accordingly their tenders were being opened. However, now category and enlistment has been removed. He requested HQ to look into the matter and do the needful.

Sh.Shiv Kumar Gupta stated that previously also they along with Sh.Varun Puri have met the Hon'ble Minister and have presented difficulties being faced by MES Contractors in Gemp. He requested members to send their point of difficulties being faced in GEMP through Mail. He requested Sh.Varun Puri to take some time from CEO GEMP. Sh.Atul Arora stated that it is not feasible to discuss all the issues related to GEMP in a meeting. In GEM there is lot of corruption. He stated that in GEMP in some tenders they are started asking security clearance. He stated that being MES enlisted contractors there is no need of separate security clearance.

Hony. Gen. Secretary requested Sh.Atul Arora and other members to send their points through mail. The same would be looked in by the committee and matter will be taken up accordingly. He stated that members should send their points regarding GEMP to HQ, a seminar on the subject matter will be organized to discuss all the points.

Sh.C.Balasatish stated that certain points have been raised by Visakhapatnam Branch.

**In-appropriate Guarantee Period.**

Sh. C. Balasatish stated that in certain items like LED lights guarantee upto 5 years is to be given whereas none of the manufacturers give guarantee from 1 to 3 years. The guarantee should be realistic.

Secondly all final bills from Visakhapatnam are required to be sent to CDA Secunderbad. He stated that every contractor have to spend transportation charges upto Rs.2000/-.

Sh.Badri Mandar stated that there is no need to read out letter of a Branch, there is no need to discuss in the Council. The Branch should address letter to him and necessary action should be taken up.

Sh.R.M.Singhvi stated that during the meeting held for election, Sh.C.Balasatish has stated that all E class contractors would be promoted as D class with in three month. He requested him to update the House about the same. Sh.Lakhbir Singh stated that Sh.C.Balasatish should be authorized to take initiative along with HQ team to take this point forward.

President stated that this matter is to be taken up upto the level of Ministry. He stated that in the next council meeting we will apprise the House on this matter.

Sh.M. Sundararajan stated that HQ had asked copy to tenders of other Department where GST is being mentioned separately. He submitted some documents for the same. Second point have been sent that tender fee be accepted by eMRO. The same may be taken up.

Sh.M.Sundrarajan stated that three points have been sent by Chennai Branch:

- a) Unclaimed Security Deposits
- b) Guarantees

The works involves guarantee like waterproofing, anti-termite, weather coat etc. are got executive by the Department i.e. GEs/AGEs and concerned JEs and the contractor have no other option to deviate from their methodology of workmanship. All the materials involved are approved by GE and contractors are bound to purchase only the particular make mentioned in the CA. When there is a defect or failure only the contractor is made responsible and it comes under his liability and the contractor is ordered to redo the work free of cost.

**c) Release of Performance Guarantee.**

The Performance Guarantee should be released to the contractor if there is no demand or the liability period is completed. No demand certificate or request letter from the contractor to release PG should not be demanded.

President stated that points received from Visakhapatnam and Chennai Branch shall be included in the Plan of the year.

Sh.Bharat Bhasin suggested that the points received from Branch must be submitted to the Hony.Gen.Secretary and after elaborate discussion the points which are considered to be included in the plan of the year should be included in the proceedings and the same should be taken up by the Hony.Gen. Secretary in the Council. The dais should be controlled by the General Secretary and President.

Hony.Gen.Secretary stated that as per Hony. Treasurer Sh.Shiv Kumar Gupta we may require to open a new Bank Account. He requested council authorize HQ for the same. The Council agreed and authorized the HQ office bearers to take necessary action to open new Bank Account.

President Sh.G.S.Mago requested Sh.Lakhbir Singh to apprise the House regarding the outcome to meeting held yesterday.

Sh.Lakhbir Singh stated that an unwanted dispute was raised on the HQ team of office bearers for the term 2023-25 which was elected in a democratic way. He stated that he want to apprise the House about the efforts made by HQ team to resolve the same. He stated that some of HQ office bearers have been trying to convince them to withdraw the decision given by the defunct DRRC. Member of Delhi Branch has published this matter in the media and emails were sent to the Department. Emails were sent to the Council Members due to which image of our Association has been damaged especially due to the letters sent to the Department that DRRC has given decision hence the new team should not be recognized. It is very sad that such persons are our members. After discussion held it was decided that five representatives from both side will discuss the matter. HQ office bearers have tried to get the matter resolve amicably they have visited past President at Gurguon where other Past presidents were also present so that matter be resolved without approaching the Hon'ble Court. It was come to our notice that they want that myself and President should meet them. Yesterday at about 11 PM they wanted that President and myself should go to meet them. Even today morning we have talked with them. Only due to ego of few members the matter is not yet resolved. He stated he still feel that matter will be sorted out. He stated that it was said that they will get office sealed and stop operation of Bank account. Sh.Lakhbir Singh stated that he only want to apprise the House that HQ has tried their level best to get the matter resolved without approaching the Hon'ble Court. We are still open that they should withdraw all the letters issued and withdraw the things to approach the Hon'ble Court.

Sh.R.K.Sharma stated that to increase the strength of the Association they have discussed with contractors want to get four Branches of the Association opened. He wanted to know the formalities for the same. President appreciated efforts of Sh.R.K.Sharma. He stated that to open a new branch total 30 new members are required i.e minimum 25 enlisted builders/contractors and five as Associate members.
